Once a civil divorce
is granted both
the wife and the
husband can remarry
civilly. In it is
not comprehensible
that the Bet Din ~~will~~

for her. She can
accept it or not.

her. They then can
proceed and officiate
at a marriage
ceremony for the
husband. If the
wife elects never

that is her business.
