AA IS THE YOUNGEST OF ALL HER SIBLINGS. SHE WAS SPOILED ROTTEN. WHAT EVER AA WANTED AA GOT. AA HAS A VERY GREAT FEELING ABOUT HERSELF.

AA MET AND MARRIED A MAN
9 YEARS OLDER WHO IS
DIVORCED AND HAS ONE CHILD
FROM HIS PREVIOUS
MARRIAGE . THE MAN TREATS
AA AS NOT THE QUEEN BUT AS
THE KING. WHAT EVER AA
WANTS AA GETS. AA HAS
REMAINED MARRIED ALMOST
60 YEARS. COULD IT BE THAT
AA FOUND IN HER MARRIAGE
A CONTINUATION OF HER

PRIOR LIFE AND AN ADMIRER TO BOOST HER EGO?

BB IS TREATED BY HER HUSBAND AS THE KING OF THE CASTLE. SHE IS THE BOSS IN EVERY THING. HER HUSBAND UNFORTUNATELY HAD A UROLOGICAL OPERATION. AS A RESULT HE IS UNABLE TO HAVE AN ERECTION. HE COMPENSATES BY KISSING BB PETTING HER TELLING HER HOW MUCH HE LOVES HER AND FINDING SOME THING NICE TO BOOST HER EGO EVERY DAY. BB IS SATISFIED. QUESTION. CAN EGO SATISFACTION REPLACE SEXUAL INTERCOURSE ?

CC WAS IN A MARRIAGE WHERE HE CONSTANTLY ARGUED WITH HIS WIFE . IF HE SAID IT IS DAY HIS WIFE SAID IT IS NIGHT. THIS KEPT ON FOR YEARS THEY HAVE CHILDREN. FINALLY CC GOT DIVORCED. HE MARRIED A WOMAN WHO PLAYS BY HIS RULES. SHE DEFERS TO HIS JUDGMENT.

HIS WIFE MARRIED ANOTHER MAN WHO DEFERS TO HER WISHES. QUESTION. IS EGO SATISFACTION A FOUNDATION FOR A SUCCESSFUL MARITAL RELATION SHIP?

DD HAS 7 CHILDREN . HER HUSBAND IS ADAMANT IN HAVING EVERYTHING DONE HIS WAY. IT IS EITHER MY WAY OR

THE HIGHWAY. AFTER 35 YEARS OF MARRIAGE DD SPILT AND GOT A DIVORCE. SHE MARRIED A MAN WHO DOES HER WISHES. QUESTION. IS THIS EVIDENCE OF THE IMPORTANT ROLE OF EGO IN MARRIAGE ?

EE IS AN ADOPTED CHILD. WHEN EE GREW UP SHE JOINED THE ARMY. SHE HAS REFUSED TO HAVE ANYTHING TO DO WITH HER ADOPTED PARENTS. EE WAS ALWAYS DEPRESSED. JOINING THE ARMY PLACED HER IN A VERY STRUCURED ENVIRONMENT.

QUESTION. IS IT POSSIBLE THAT THE REASON EE REFUSES TO HAVE ANY THING TO DO WITH HER ADOPTED

PARENTS IS BECAUSE THEY REMIND HER OF THE FACT THAT SHE WAS ABANDONED BY HER BIRTH MOTHER? SHE BELIEVES THERE MUST BE SOMETHING WRONG WITH HER OTHERWISE HER MOTHER WOULD NOT HAVE GIVEN HER AWAY IN ADOPTION. . . THAT SHE IS REALLY NOT IMPORTANT. THAT IS WHY HER BIRTH MOTHER ABANDONED HER AND GAVE HER UP FOR ADOPTION. TO HER AGRIEVED MIND HER ADOPTED PARENTS ARE PART OF THIS CONSPIRACY THAT SHE IS NOT IMPORTANT. SHE WAS ALWAYS DEPRESSED.

NOW IN THE ARMY SHE FOUND A PLACE FOR HERSELF. SHE NO LONGER IS DEPRESSED. SHE FEARS THAT HAVING CONTACT WITH HER ADOPTED PARENTS WOULD THROW HER BACK TO DEPRESSION.

IS THIS ANALYSIS SOUND? IS EGO AND THE LACK OF EGO CAUSING DEPRESSION THE REASON WHY EE REFUSES TO HAVE ANY CONTACT WITH HER ADOPTED PARENTS?

FF COMES FROM A DIVORCED HOME. HE WAS RAISED BY HIS MOTHER. THE ONLY CONTACT HE EVER HAD WITH HIS FATHER WAS WHEN HIS FATHER MET HIM IN A NEUTRAL PLACE FOR HIS

VISITATION RIGHTS. FF ALWAYS WAS DEPRESSED. WHEN HE GREW UP BEGAN EARNING MONEY AND MARRIED HIS DEPRESSION DISAPPEARED. FF REFUSES TO VISIT HIS FATHER'S HOME OR HAVE ANY THING TO DO WITH HIS FATHER'S OTHER CHILDREN FROM A SCOND MARRIAGE . FF INSISTS THAT HIS FATHER VISIT HIM .

QUESTION. COULD FF CONSIDER HIS FATHER AS HAVING ABANDONED HIM BY NOT RAISING HIM? NEVER MIND THAT THE COURT RULED OTHERWISE? HE REFUSES TO HAVE ANY RELATIONSHIP WITH THE OTHER CHILDREN OF HIS FATHER BECAUSE HE

WOULD BE REMINDED THAT HE IS NOT ONE OF THEM. HE FEELS NO AFFINITY WITH THEM. HE EVEN DESPISES THEM. .AND IS POSSIBLY JEALOUS THAT THEY WERE RAISED BY TWO PARENTS WHILE HE WA RAISED BY ONLY ONE. FF POSSIBLY FEARS THAT HAVING ANY CLOSER RELATIONSHIP WITH HIS FATHER WOULD BRING BACK THE DEPRESSION. IS THIS ANALYSIS CORRECT? IS EGO THE CONTROLLING FACTOR?

GG IS ADOPTED. GG WAS ALWAYS DEPRESSED. GG WENT ON DRUGS AND OVERDOSED AND DIED.

QUESTION. WAS GG DEPRESSED BECAUSE HE FELT HE WAS ABANDONED

BY HIS BIRTH MOTHER WHEN SHE AGREED TO GIVE HIM UP FOR ADOPTION? THIS CASE IS SIMILAR TO THE CASE OF EE. HOWEVER HERE THERE IS A TRAGIC CONCLUSION

HH WAS RAISED BY HIS MATERNAL MOTHER. HIS FATHER AND MOTHER DIED FROM DRUG OVER DOSE. HH WAS ALWAYS DEPRESSED. HE DOES NOT TAKE ANY DRUGS BUT SMOKES. HE GOT CANCER. QUESTION IS EGO THE REASON?

HH was harmed when in the womb his mother was on drugs. Could it have harmed him psychologically that both parents died from overdose. He feels

that both parents abandoned him by not controlling their habit. He was not as important to both of them as their habit of drugs. That may be part of the reason for his depression. Unfortunately he is not able to pry loose of his depression.

JJ IS THE YOUNGEST CHILD. HE IS SPOILED ROTTEN. HE IS ELEVEN YEARS YOUNGER THAN HIS BROTHER . JJ HAS A VERY SUCCESSFUL CAREER AND BUSINESS. HE IS MARRIED AND HAS CHILDREN JJ DOES NOT SPEAK TO HIS OLDER BROTHER. THE OLDER BROTHER LIKewise DOES NOT INITIATE ANY CALLS TO JJ NOR DO THEY VISIT EACH OTHER. JJ ALWAYS ARGUES WITH BOTH HIS

BROTHER AND FATHER. HE ALWAYS WANTS TO SHOW THAT HE KNOWS BETTER AND IS SMARTER. JJ ALWAYS THINKS OF HIMSELF AS BEING SUPERIOR TO HIS BROTHER AND TO HIS FATHER.

HIS WIFE LETS JJ MAKE LL THE DECISIONS. SHE IS HAPPY WITH THAT ROLE. JJ HAS VERY GOOD MARRIAGE .

DOES JJ PRESENT A PERFECT PICTURE OF THE ROLE OF EGO IN HIS RELATIONSHIP WITH HIS BROTHER AND FATHER?

HE IS 15 YEARS YOUNGER THAN HIS SISTER AND SHE STILL REMAINS HIS

SECOND MOTHER. HE VISITS HIS SISTER AND IS PERFECTLY SATISFIED TO TREAT HER WITH RESPECT THAT HE DOES NOT SHOW TO HIS OLDER BROTHER. JJ ACCEPTS THE ROLE THAT HIS OLDER SISTER REMAIN HIS SECOND MOTHER EVEN NOW THAT HE IS GROWN UP.

HOWEVER HE IS UNWILLING TO ACCEPT THE ROLE THAT HE IS YOUNGER THAN HIS BROTHER

AND LESS **SMARTER.**

THAT POSSIBLY MAY BE THE REASON WHY HE AVOIDS HIS BROTHER.

HE REFUSES TO HAVE HIS FATHER HANDLE ANY OF HIS BUSINESS EVEN THOUGH JJ MUST PAY TO HAVE THE SERVICE PERFORMED BY A STRANGER. POSSIBLY JJ DOES NOT WANT HIS FATHER TO KNOW HIS SECRETS THAT THE FATHER CAN SHARE WITH HIS OLDER BROTHER. ALSO JJ WANTS TO SHOW AND PROVE TO HIMSELF THAT HE NO LONGER NEEDS HIS FATHER. HE IS NOW GROWN UP AND HAS OUTGROWN THE ROLE OF YOUNGER CHILD. HE IS TOO IMPORTANT.

HIS BROTHER ALSO AVOIDS HIM BECAUSE THE OLDER BROTHER IS UNWILLING TO ACCEPT THE NEW ROLE

THAT JJ DEMANDS THAT JJ IS AS SMART OR SMARTER THAN HIM.

JJ PLAYS GOLF LIKE ALL IMPORTANT PEOPLE. JJ MAKES YEARLY A HUGE CHARITABLE CONTRIBUTION TO A CHARITY THAT NAMED A BUILDING AFTER HIM.

DON'T ALL THESE ACTIVITIES POINT TO THE LARGE ROLE OF EGO?

KK MARRIED A SECOND TIME . SHE WAS CONTINUOUSLY ARGUING WITH HER NEW HUSBAND. HER HUSBAND LOST HIS TEMPER AND SLAPPED HER HARD ACROSS HER FACE. KK SUED FOR DIVORCE.

QUESTION: IS IT NOT TRUE THAT DOMESTIC VIOLENCE NOT ONLY IS PHYSICAL BUT ALSO EMOTIONAL? WHEN A GROWN WOMAN IS SLAPPED DOES IT NOT VIOLATE HER EGO HER SELF ESTEEM ? ISN'T PHYSICAL ABUSE NOT ONLY PHYSICAL ;BUT ALSO PSYCHOLOGICAL? ISN'T GETTING SLAPPED BY ONE WHO PURPORTS TO LOVE HER VIOLATES HER VERY ESSENCE ?DOESN'T IT DESTROY HER SELF RESPECT? LL WAS MARRIED FOR HALF A YEAR . HIS WIFE GOT PREGNANT AT THE SAME TIME SHE WAS DIAGNOSED WITH COLLIDES .

LL HAD TREATED HIS WIFE WITH THE GREATEST DIGNITY. HER WISH WAS HIS COMMAND. NEVERTHELESS HER PARENTS BLAMED LL THAT HE IS THE CAUSE OF HER ILLNESS. THEY SUCCEEDED IN ALIENATING HER AFFECTIONS AND SHE SUED FOR DIVORCE. LL FOUGHT THE DIVORCE BECAUSE HE LOVED HIS WIFE AND DID NOT WANT HIS SON TO GROW UP WITH ONE PARENT. HE WANED HIS SON TO HAVE A NORMAL FAMILY. LL RETURNED TO SCHOOL AND BECAME A PROFESSIONAL. AND WENT INTO BUSINESS. HOWEVER HIS WIFE AND HER

PARENTS WERE ADAMANT AGAINST HER RETURNING.

LL FINALLY GOT THE MESSAGE AND AGREED TO GRANT HER A GET A JEWISH DIVORCE. HE FINALLY REALIZED THAT HIS X IN LAWS WERE DOING HIM THE BIGGEST FAVOR. HE GOT RID OF AN IMMATURE WIFE AND MEDDLING IN LAWS. IF THEY CRIPPLED HIS SON THEY WOULD DEFINITELY CRIPPLE EVEN TEN CHILDREN IFHE WOULD HAVE REMAINED MARRIED AND HAD ADDITIONAL CHILDREN.

LL MARRIED A WOMAN NEVER MARRIED BEFORE A DECADE YOUNGER THAN HE IS . SHE HAS HER OWN MIND

AND JEALOUSLY GUARDS HER OWN DECISIONS. THE FAMILY OF HIS SECOND WIFE OBJECTED TO THE MARRIAGE ORIGINALLY . HOWEVER ONCE THEY SAW THAT THE SECOND WIFE IS VERY HAPPY AND REFUSED TO ABIDE BY THEIR ADVICE THEY ACCEPTED LL. THAT WAS THE CRITICAL DIFFERENCE BETWEEN THE TWO WIVES.

WIFE # 1 DID NOT REMARRY UNTIL 14 YEARS AFTER LEAVING LL. BY THIS TIME HER MOTHER HAD DIED. HER FATHER REMARRIED. HIS MARRIAGE DID NOT LAST. BY THIS TIME WIFE #1 HAD MATURED AND LEARNED HER LESSON TO HAVE HER HUSBAND COME FIRST.

QUESTION: ISN'T IT TRUE THAT WHEN LL'S WIFE ABANDONED HIM HIS EGO AND SELF ESTEEM WAS CRUSHED? WHEN LL RETURNED TO SCHOOL AND BECAME A PROFESSIONAL THEN WENT INTO BUSINESS HIS EGO AND SELF RESPECT WAS RESTORED? ONLY THEN DID HE REALIZE THAT IT WAS FOOLISH TO HANG ON TO AN ILLUSION TO GET HIS WIFE BACK? ONCE HE REALIZED THAT HE WAS COMPETITIVE AND FREE TO FIND AN OTHER LOVE HIS DELUSION DISAPPEARED. WIFE #1 WAS NOT THE ONLY WOMAN IN THE WORLD. IN FACT SHE AND HER FAMILY WERE THE WORST POSSIBLE CHOICE. HE HAD DONE ALL HE

COULD DO FOR HIS SON. HE HAD TO GO ON WITH HIS LIFE. HE DID NOT ABANDON HIS SON. IF HIS SON IS CRIPPLED HE WOULD DO WHAT EVER HE COULD TO HELP HIS SON . IT IS HIS SON'S RESPONSIBILITY TO GO ON WITH HIS LIFE.

HIS SON SUFFERED FROM DEPRESSION FOR MANY YEARS. ONCE HE STARTED EARNING MONEY AND GOT MARRIED HIS DEPRESSION DISAPPEARED. HE DOES NOT HAVE ANY RELATIONSHIP WITH THE CHILDREN OF HIS FATHER FROM HIS SECOND MARRIAGE. NOR DOES HE HAVE ANY RELATIONSHIP WITH HIS MOTHER'S SON FROM HER SECOND

MARRIAGE HIS RELATIONSHIP WITH HIS FATHER IS ONLY OCCASIONALLY IN A TELEPHONE CALL. HE REFUSES TO VISIT HIS FATHER'S HOUSE. QUESTION : COULD THE REASON BE BECAUSE LL'S SON FOUND A NEW LIFE AND PLACE

WHERE HE COULD FUNCTION AND FEEL IMPORTANT IN HIS NEW LIFE. VISITING HIS FATHER'S HOUSE WOULD ONLY REMIND HIM THAT HE DOES NOT BELONG. HIS EGO WOULD AGAIN BE DESTROYED. HE WOULD POSSIBLY RETURN TO HIS DEPRESSION ???

MM REFUSES TO VISIT WITH HIS OLDER SISTER OR HAVE ANY RELATIONSHIP WITH HER CHILDREN. MM ALWAYS

WAS IN COMPETITION WITH HIS SISTER.
MM IS A PROFESSIONAL MAKES A GREAT
SUM OF MONEY IS MARRIED AND HAS A
CHILD .

QUESTION : IS THE REASON FOR MM'S
BEHAVIOR BECAUSE HE HAS AN
INFERIORITY COMPLEX. HE DEEP DOWN
DOES NOT FEEL HE IS SUPERIOR TO HIS
SISTER. AVOIDING HER AND HER
CHILDREN DOES NOT CONFRONT HIM
WITH THIS PROBLEM OF TESTING IF HE
IS REALLY AS IMPORTANT AND GET EGO
SATISFACTION AS HE WISHES???
